

### **Protecting your private information**

This statement of privacy applies to [www.annemariesdance.com](http://www.annemariesdance.com) and Annemarie's Dance Centre and governs data collection and usage. ### **Collection of your personal information**

In order to better provide you with products and services offered on our site, Annemarie's Dance Centre may collect personally identifiable information such as your:

### **We do not collect any personal information about you unless you voluntarily provide it to us**

### **Automatically collected information**

Please note that we may not be able to comply with requests to delete your personal information if it is necessary to: Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by you, or reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform a contract between you and us; Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity; Debut to identify and repair errors that impair existing intended functionality; Exercise free speech, ensure the right of another consumer to exercise his or her right to free speech, or exercise another right provided for by law; Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your information consent; Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us; Comply with an existing obligation; or Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.
